

Privacy and Cookie Policy

We understand the importance of privacy of information and personal data you share with us. By submitting your information and personal details you consent to their processing.

Server log files: Website server records your IP address in a standard server log file. Server logins are used by us to diagnose problems with our server, to analyse how our site is used, to produce statistics and to improve our website. IP logs do not contain any personal data.

Contracting 3rd party service providers

To analyse website traffic and the rate of use of the website we use Google Analytics and Salesmanago tools. These cookie files are used for statistical purposes (website traffic analysis) and TecSolum may collect information on the website user's visits on other websites making use of services of this type.

Cookie files

Cookies are small text files on the website that are stored by the browser on your computer. Most often they contain website address, time of storage on a user's device and their own unique identifier.

Cookies are used to improve your browsing experience and to collect statistical data which help us understand how sites are being used by the visitors. This enables further improvement of Website structure and contents.

Web browsers accept cookies automatically. You can block cookies on your web browser any time, but this may hinder website performance.

These data are downloaded and stored only for the purpose of contacting you to present our offer, verifying the service provided by us or in connection with any other issue indicated by you in the form. If these data are used for sending an e-mail advertising our services or cooperation options and you do not want to receive more such e-mails, you can always withhold your consent to receive such information in the future.

Recruitment form data: In the form, please give full name, telephone and e-mail address of the person who would like to apply for work in our company. These data are downloaded and stored only for the recruitment purposes in order to contact you in connection with the recruitment process at the number provided by you.
